

Vendor Agreement

Thank you for your interest in the Queen Bee Market! We are excited for your willingness to make the Queen Bee a modern and fresh handmade and vintage market focused on carefully curated quality over quantity. We are dedicated to providing exposure for handmade artists and vendors as well as an amazing shopping experience for the community. We want the show to be well rounded, so we have limited the number of vendors spots available within each category. This will eliminate the competition between vendors and allow for a pleasing shopping experience for all. We do not accept direct marketing vendors or non-handmade products (with the exception of vintage items).

Upon review of your application and acceptance to the Queen Bee Market, vendors agree to the following:

BOOTH & FEES: We offer two booth sizes, 6x8 for \$225 and an end cap that is 6x12 for \$325. In all cases booth sizes include the area for you to stand, as well as any product or displays you place on the floor. Everything must be in the space! The booth fee for vendors of the Queen Bee Market is non-refundable if accepted. There is an additional \$25 nonrefundable application fee for new vendors. **NOTE:** your booth fee and application fee (new vendors) must be received in order to consider your application complete.

YOU WILL NOT GET NOTIFICATION OF ACCEPTANCE UNTIL YOUR CHECK HAS BEEN RECEIVED! Do NOT fill out the application and wait.

After being accepted and checks are deposited, booth fees are non-refundable and non-accepted vendors will have booth fees shredded.

DISPLAY & SET UP: Set-up times will be received in future emails. Displays **MUST BE COMPLETE** by 3:30pm on Friday. Breakdown will follow at the end of the show on Saturday and **MUST BE COMPLETE** by 5:30pm. There will be a \$50 charge to breakdown any displays that are remaining. As a vendor, you are responsible for the necessary items for your space: tables (if not reserved on the above application), table cloths, mirrors, extension cords, décor etc.

As you receive emails from now until the show, you will see there will be a heavy emphasis on creating a beautiful, free-standing, enclosed booth space. **WE REQUIRE THAT BOOTHS HAVE A BACK "WALL" (MATERIAL OF YOUR CHOICE)** and highly encourage side walls also.

We've had too many shows where we paid for tables for vendors and only a few actually get used, so we are no longer offering tables. The only exception is for vendors coming from out of state. In this case, please notify us separately.

Vendors are required to man their booth throughout the duration of the show. Vendors will process all transactions at their individual booths. Queen Bee Market is not responsible for lost, stolen, or damaged items.

The Queen Bee Market will do extensive advertising, but we also ask that you do advertising of your own via your blog, website, Twitter, Facebook, Instagram, etc. Social networking has been vital to the growth of the market, so please spread the word! More specific information will be sent after acceptance to the show.

While we will do our best to have WiFi, we cannot guarantee that it will be available or functioning correctly. Please have an alternate method ready (mobile hotspot, etc) to take credit card payments.

Please note- documents created for the Queen Bee Market are private property. Information is intended for vendors use only, specific to our Market, and not to be used elsewhere. Legal action will be taken if necessary to protect the integrity of the show.
